Glossary.

Assignee. A person to whom a right or property is legally assigned.

Backside. Area of land immediately behind a house.

Court Roll. Record of the proceedings of the manorial & other local Courts.

Farandell. Farandel or Farthingdeal – the fourth part of an acre or a rood.

Hereditaments. Any interests in real estate capable of being inherited.

Heriot. A tribute paid to a Landowner out of the belongings of a tenant who has died.

i.e. a death duty paid by tenants to landowners.

Lease. A contractual arrangement calling for the lessee to pay the lessor for use of

an asset.

Lugg. Measurement of land – also known as the rod, pole or perch, approx. 40 sq m

Messuage. A Dwelling House with Outbuildings & land assigned to its use.

Moiety. A half share. Parrock. Paddock.

Reversion. The right of the original owner or their heirs to possess or succeed to

property on the death of the present possessor or at the end of a lease.

Tenement. Any structure attached to the land.

Thoroughs. Furrows between 2 ridges to drain off water.

Note. The name Butcher is clearly written as such but possibly should be Boucher. Note. The interest on this mortgage was 4.5%. – It was reconveyed in June 1766.
